Brief description of the policy, service or function covered by the EIA	Housing Solutions and Support is responsible for statutory service delivery to vulnerable citizens. This includes people who sleep rough, single homeless and families, including temporary accommodation (TA) and move-on. As part of this statutory duty, the service delivers a health and wellbeing support offer to homeless households, which the service has now received £200k funding for through a Public Health Service Grant to deliver this same service. As such, £200k has been identified as a saving from the base budget. This is therefore a neutral impact on service recipients, with the provision continuing but funded via a different source.
